lots described above for personal use. I represent that all heirs and relatives of the party referenced above have declined or stated no interest in use of said burial lots for personal purposes.

12. I further represent that at no time in the past have the stated burial lots been probated as part of any individual's estate named above and that same have remained in the name of the above individual since the date of his/her death.
13. I represent that if any other relative or heir of the parties named above indicate an interest in personal use of the burial lots described above that I will immediately notify Campbell Township of said claim of interest.
14. I recognize that if Campbell Township offers to me or other members of my family the right to utilize the burial plots as described above that I will hold harmless and indemnify Campbell Township from any and all claims, actions, liability, damages, costs and attorney fees incurred by or imposed upon the township as a result of the use of the burial plots by me, and further, that this representation forms an agreement with Campbell Township regarding this matter.
15. That the Township of Campbell may rely upon the representations contained herein as true, the affiant having fully disclosed the facts and circumstances pertaining to the above described burial plots.
16. That in the event there is a conflict or claim regarding the burial lots and my right to use Same or to grant the use of same to other members of my family, I agree that I will Forthwith terminate any further claim of right or title until I have resolved said conflict to The satisfaction of the township and at my own expense, including all attorney fees and Costs, so as to provide the Township of Campbell with appropriate documentation or Court orders which will finally adjudicate and determine the rights of the respective Parties with respect to the use, ownership and holding of the burial lots described above.

This affidavit and agreement is made by the undersigned so as to induce the Township of Campbell to allow the undersigned, or the designated members of his family, as he Directs, to use and possess the burial lots described above and to transfer title to him in The event the Township of Campbell determines that such is in its best interest.
18. That the consideration for this agreement is the promises and conveyances contained Herein and the right to use and possess the burial lots described herein.
