Regular meeting began at 7:00 with the Pledge of Allegiance.

Roll Call was taken. All board members were present.

11 Visitors Present

Approval of the Agenda – Motion by Pepper, Support by Jackson. Approved.

Approval of January meeting minutes – motion by Pepper, support by Jackson. Approved.

Public Comment – Phil Heschke was present and asked if anyone had any questions. There were none. James Nave from Life EMS gave information on response times in Campbell Township and discussed challenges with Life EMS serving the township.

- Annual elections were held, and a motion was made by Pepper, supported by Jackson to approve the following: Chief – Paul Immoos; Assistant Chief – Randy Willette; Training Officer – Hunter Engels; Maintenance Captain – Lenny Satterley; Treasurer – Bonnie Cronk; Secretary – Chris Saucier. Motion passed.

Clarksville-Morrison Lake Sewer Authority – Dan gave an update on the most recent meeting.

Old Business –

- Township Parking Lot is still in the drawing process.
- Battery backup is now installed and running.
- Clerk Newman gave a report on the Presidential Primary, and gave an update on the May 7th election.
